### **Eligibility**

University Scientists in Canada, Government Scientists in Canada and Private Sector Researchers in Canada. Note: Private Sector Researchers are encouraged to work with the Government or University Scientists.

### **Maximum Project Value**

Must not exceed \$1M in total for the five years

### **Indirect Costs**

15 %

## **How to Apply**

Submit your completed LOI using the electronic form provided in the For More Information section. All LOI submissions will receive an email confirming receipt within two to three business days.

Researchers are not required to submit their LOI to the Office of Research for approval before submission to the Sponsor. Researchers are asked to send a copy of their proposal to the Office of Research for information purposes only (no OR5 required at the LOI stage). Researchers will be notified by the sponsor if they have been invited to submit a full proposal.

Full Proposal - Those invited to submit a full proposal must submit their full proposal to the Office of Research two weeks in advance of the sponsor's deadline, along with a signed OR-5 form.
