- 1. The Nominated Principal Applicant (NPA) must be an independent researcher [2].
- 2. For the purposes of this funding opportunity, the Nominated Principal Applicant must have an academic, clinical, or research appointment by the application deadline date at an eligible institution (see <u>Institution Eligibility Requirements</u> [3] for eligibility process and associated timelines).
- 3. The Nominated Principal Applicant must have successfully completed one of the sexand gender-based analysis training modules available online through the CIHR Institute of Gender and Health. Please select and complete the training module most applicable to your research project (Sex, Gender and Health Research Guide [4])
- 4. The team must involve at least one <u>knowledge user</u> [5] (either as Principal Knowledge User, a knowledge user or a collaborator)
- 5. For any research applications involving First Nations, Inuit, Métis and/or Urban Indigenous populations, the research team must include **at least one knowledge user** who self-identifies as either First Nations, Inuit, or Métis or provides evidence of Indigenous-living experience*.
