Description

The Quadruple Aim is centred on four overarching goals to redesign health care systems: improve the patient experience of care; improve the health of populations; improve the health care provider experience; and improve value for money.

Research has a critical role to play in accelerating the identification, implementation, evaluation and spread of health care delivery system innovations with the greatest potential to achieve the Quadruple Aim and health equity for all. In recent years, several Canadian provinces and territories have made significant changes to the financing, governance, funding and delivery of health care services, including public health services. Select examples of these changes include the shift away from regionalized towards centralized governance models of public health and healthcare delivery, implementation of integrated care delivery systems, interdisciplinary team-based models for primary health care delivery with incentive-based funding and, most recently, large-scale implementation of virtual health care services in response to the COVID-19 pandemic.

Eligibility

For an application to be eligible:

1. The research must be co-lead by an [independent researcher](#) [2] and a [knowledge user](#) [3]* with direct experience in the relevant research area. One must be listed as the Nominated Principal Applicant. < >If the Nominated Principal Applicant is an independent researcher, you must also identify an Applicant who is a Principal Knowledge User. If the Nominated Principal Applicant is a knowledge user, you must also identify a Principal Applicant who is an independent researcher. The Nominated Principal Applicant (independent researcher or knowledge user) must be affiliated with [an eligible institution authorized to administer CIHR funds](#) [4] at the time of funding.
2. The Nominated Principal Applicant is required to complete one of the [sex- and gender-based analysis training modules](#) [5] available online through the CIHR Institute of Gender and Health. The NPA must submit a Certificate of Completion in order for grant funds to be released (see [How to Apply](#) [6] section). For additional information on sex, gender and health research, applicants are encouraged to review the [How to integrate sex and gender in research](#) [7] section on the CIHR website.
3. For any research applications involving Indigenous populations (including First Nations, Inuit and Métis) the research team must include at least one member who self-identifies as Indigenous (First Nations, Inuit or Métis) or demonstrates a track record of [meaningful and culturally safe](#) [8] involvement with Indigenous Peoples.

CMA Foundation-Specific Eligibility Requirements

- The Institution receiving the grant on behalf of the Nominated Principal Applicant must be a Qualified Donee as determined by the CMA Foundation in accordance with the [definition of the the Canada Revenue Agency](#) [9]. Funding Availability

The total amount available for this funding opportunity is \$2,600,000, enough to fund approximately 26 grants.

Maximum Project Value

- **\$500,000 is available to fund 5 applications relevant to the CIHR-IPPH Pool.**
- \$400,000 is available to fund 4 applications relevant to the CMA Foundation Pool
- \$100,000 is available to fund 1 application relevant to the CIHR-IMHA Pool.
- \$1,600,000 is available to fund 16 applications relevant to the CIHR - IHSPR Pool. Of this \$1,600,000, \$100,000 is available to fund 1 application relevant to the CIHR-IA relevant research area
- Applications relevant to each pool will be funded top down in order of ranking. Remaining applications in the competition will be pooled together and funded in rank order.
