Description

The 2018 Early Career Investigator Awards in Circulatory and Respiratory Health provide recipients with the opportunity to develop and demonstrate their independence in initiating and conducting research in any one of the ICRH mandate areas [1]. These awards are designed to provide protected time for early career investigators to undertake research relevant to the ICRH mandate by contributing to both salary and research allowances.

The award aligns with:

- CIHR Institute of Circulatory and Respiratory Health's (ICRH) Strategic Plan 2017-2020 research priorities: to enhance training and early career development, and to enhance the conduct of Indigenous Health Research and equitable research under ICRH's mandate areas.
- CIHR Institute of Indigenous Peoples' Health (IIPH) <u>Strategic Plan 2014-2018</u> [2]: Strategic Direction 1: First Nations, Inuit and Métis peoples and communities driving First Nations, Inuit and Métis Health research and knowledge translation.
- CIHR Institute of Nutrition, Metabolism and Diabetes' (INMD) <u>Refreshed Strategic Plan</u> 2015-2018 [3], in regard to Capacity Building.

Research Areas

Within the funding opportunity, there are two streams: one open only to Clinician Scientists, including allied health professionals, and one open to any Independent Researcher, as defined in the <u>Eliqibility Criteria</u> [4].

Eligibility

For an application to be eligible:

- 1. The Nominated Principal Applicant (NPA) must be an independent researcher [5]
- 2. The NPA must be registered at an eligible institution (see <u>Institutional Eligibility</u> <u>Requirements</u> [6] for eligibility process and associated timelines)
- 3. The NPA must also:
 - 1. Be an early career investigator [7] at the funding start date.
 - 2. Have a written commitment from their Institution, via a letter from the Dean of their primary Faculty or Research Director of their primary Research Institute which accompanies the application, that includes: >
 - A commitment that the NPA will hold a full-time faculty or equivalent position
 - A commitment to protect a minimum of 75% of the NPA's time to research activities relevant to the <u>Objectives</u> [8] and Research Areas described in the <u>Description</u> [9] section, limiting clinical service, teaching and/or administrative activities to a maximum of 25% of the NPA's time for the duration of the award
- 4. If applying as a Clinician Scientist, the NPA must, at the time of application, hold a recognized training certification to practice as a <u>health professional</u> [10], as well as a full-time faculty or equivalent position as a clinician-scientist (see <u>How to Apply</u> [11] section).

\$2,070,000, enough to fund up to six (6) awards.

Maximum Project Value

\$115,000/year to a max of \$345,000 per award

^{**}In order to increase capacity and allow as many researchers as possible to benefit from federal, peer-reviewed funding, the NPA may not hold a peer-reviewed grant, neither as NPA or Co-Investigator, in the amount of \$150,000 or more per year for a period of two (2) or more years, nor another federally funded salary award (CIHR, Natural Sciences and Engineering Research Council – NSERC, Social Sciences and Humanities Research Council – SSHRC).**
