The specific objectives of this funding opportunity are:

- the health research landscape that will contribute to the advancement of research consistent with the mandate of CIHR;
- to support dissemination events and activities that focus on the communication of health research evidence to the appropriate researcher or knowledge-user audiences, tailoring the message and medium as appropriate; and
- to support activities and events that ensure the inclusion and meaningful representation
 of individuals who have historically faced barriers in the research ecosystem, including
 but not limited to those marginalized by gender, Indigenous Peoples, racialized
 minorities, persons with disabilities, and members of LGBTQ2S+ communities.

Eligibility

- 1. The Nominated Principal Applicant must be one of the following:< >An <u>independent researcher</u> [4]A <u>knowledge user</u> [5]A <u>trainee</u> [6]An individual affiliated with an Indigenous non-governmental organization in Canada with a research and/or knowledge translation mandate. A Canadian non-governmental, not-for-profit organization (including community or charitable organizations). An Indigenous non-governmental organization in Canada with a research and/or knowledge translation mandate. CIHR Contact Centre.
- 2. At the time of application, individuals applying as Nominated Principal Applicants (as defined in 1a-d above) must be affiliated with one of the following institution types (see the <u>CIHR Application Administration Guide Part 4</u> [7] for eligibility process and associated timelines):
 - 1. Canadian post-secondary institutions or their affiliated institutions including hospitals and research institutes;
 - 2. Canadian non-federal government departments or agencies, including regional health authorities when specific programs of those departments or agencies do not fund the activity that forms the subject matter of the grant; or
 - 3. An Indigenous non-governmental organization in Canada with a research and/or knowledge translation mandate.
- 3. Activities/events starting or taking place before the funding start date are not eligible for funding through this opportunity.
- 4. Applicants are not eligible to apply for additional funding for an activity or event that has been previously funded by CIHR.
- 5. Multiple applications for the same activity or event submitted by either the same Nominated Principal Applicant or a different one are not allowable. In such cases, the first application submitted through ResearchNet will be considered and reviewed. Any subsequent applications will automatically be withdrawn.
- 6. The Nominated Principal Applicant must have successfully completed one of the sexand gender-based analysis online training modules [8] through the CIHR Institute of Gender and Health and submit a Certificate of Completion (see <u>How to Apply</u> [9] section). Please select and complete the training module most applicable to your planning or dissemination event or activity. Other applicants are encouraged to complete a training module; however, this is not a mandatory eligibility requirement. For additional information on sex, gender and health research, applicants are encouraged to review the "<u>How to integrate sex and gender in research</u> [10]" section on the CIHR website.
- 7. Any applications involving Indigenous Peoples must include a knowledge user who self-identifies as Indigenous (First Nations, Inuit or Métis) or provides evidence of having meaningful and culturally-safe involvement [11] with Indigenous Peoples.
- 8. For all sponsor funding where funds are reserved for Early Career Researchers, the NPI
