Description

The goal of the Transitions in Care (TiC) CIHR multi-Institute initiative is to improve the health and wellness of Canadians by supporting research that transforms the health system to optimize the outcomes of patients experiencing transitions in care.

[About the TiC Team Grants](#) [2]

This funding opportunity is one of several planned as part of the Transition in Care (TiC) Initiative. The focus is to support inter-disciplinary teams that are poised and ready to optimize transition in care outcomes. The grants will provide support to implement, evaluate, spread, and scale pragmatic solutions to problems associated with transitions in care from a clinical, health care or health system perspective.

The TiC team grants are modeled from the [Partnerships for Health System Improvement \(PHSI\) and eHealth Innovation Partnership Program \(eHIPP\)](#) [3] approaches and therefore utilize a partnership approach where multidisciplinary research teams (including researchers, clinicians, patients, family members, care-givers, decision-makers, and electronic health innovation partners (as required)) will identify ways to develop, implement, and/or scale and spread (share) solutions into practice to optimize outcomes during transitions in care.

As a result, there are two (2) application streams for this funding opportunity:

- Stream 1: PHSI solutions for transitions in care gaps;
- Stream 2: eHIPP solutions for transitions in care gaps.

Eligibility

1. The Nominated Principal Applicant (NPA) must be an [independent researcher](#) [4] appointed at an eligible institution (See [Institutional Eligibility Requirements](#) [5] for eligibility process and associated timelines).
2. The research team must include Principal Applicants from each of the following roles (including the Nominated Principal Applicant). Note that one individual can represent more than one role.
 1. A scientific lead (an [independent researcher](#) [4]);
 2. A clinical lead;
 3. Patient/family/caregiver;
 4. A health system decision-maker;
 5. An eHealth innovation partner (Stream 2 only).
3. The NPA must have successfully completed one of the sex- and gender-based analysis [training modules](#) [6] available online through the CIHR Institute of Gender and Health and have submitted a Certificate of Completion (see How to Apply section).
4. Any research applications involving Indigenous Peoples must include a [knowledge user](#) [7] who self-identifies as Indigenous (First Nations, Inuit or Métis) or provides evidence of having meaningful and culturally-safe involvement with Indigenous Peoples. (Updated: 2018-11-14)

Mitacs Funding Eligibility

In addition to the above:

- If applying for the additional funding from Mitacs, the team must include at least one graduate student and/or post-doctoral fellow in the field of transitions in care; must involve a partner organization (Updated: 2018-10-22) that meets Mitacs [partner organization eligibility criteria](#) [8] (for-profit and not-for-profit organizations in Canada); and must contact [Mitacs](#) [9] to obtain their application form.

Funding Availability

The total CIHR amount available for this funding opportunity is \$9.6 million enough to fund approximately ten (10) grants.

- Of this \$9.6 million:
 - \$2.88 million is available to fund applications relevant to Stream 1: PHSI solutions for transitions in care gaps (three [3] grants).
 - \$6.72 million is available to fund applications relevant to Stream 2: eHIPP solutions for transitions in care gaps (seven [7] grants).

Maximum Project Value

The maximum CIHR amount per grant is \$240,000 per year for up to four (4) years for a total of \$960,000 per grant.

Applicants must secure, by the application deadline, partnership contributions equivalent to a minimum of 30% of the total grant amount requested, with a minimum of half (i.e., 15%) of the amount representing a cash contribution (i.e. a total of \$288,000 partner match required per grant with minimum of \$144,000 as a cash contribution per grant), for a total grant value of up to \$1.248 million per grant (Updated: 2018-09-13) over four (4) years. Mitacs Funding: Additional funding is available to fund internships for graduate students and post-doctoral fellows in transition in care projects. If requested and found relevant, this funding might bring the total grant over the \$1.248M maximum identified above.

- Each internship unit under Mitacs Accelerate is valued at \$15,000, which is cost-shared by Mitacs and the partner (for-profit and not-for-profit organizations within Canada).
- Each Elevate postdoctoral fellowship is for two years and is valued at \$120,000, which is cost-shared by Mitacs and the partner (for-profit and not-for-profit organizations within Canada).
- Allocation of funds from the required 30% match contribution for the TiC Team Grant are not eligible as a partner contribution to fund Mitacs internships.
- Mitacs funds cannot be used towards the 30% matching requirement.
