# **Description**

The Species at Risk Stewardship Program (SARSP) includes the Species at Risk Stewardship Fund, as well as the Species at Risk Research Fund for Ontario (SARRFO).

The objectives of the Species at Risk Stewardship Program (SARSP) are:

- Improving the status of species at risk and their habitats by supporting stewardship and recovery actions;
- Encouraging stewardship and multi-partner approaches to species at risk protection and recovery;
- Inspiring and enabling people to become involved in species at risk stewardship through outreach, youth employment opportunities and the provision of related tools and techniques; and
- Supporting scientific research that addresses important needs and knowledge gaps related to the protection, recovery and management of species at risk and their habitats in Ontario

Although all project proposals that target species listed on the Species at Risk in Ontario List are eligible for consideration, targeted priorities have been established for the 2019-20 funding year. - Academic institutions
- Conservation Authorities
- Individual
- Consulting company
- Business
- Industry organizations
- Landowners and farmers
- Municipal and local governments
- Non-government organizations

## **Funding Availability**

Other contributions or funding

Project proposals that include matching contributions (in-kind and financial) from a variety of sources are encouraged. Matching funds can either be matching dollars, in-kind donations, or a combination. The amount of matching funds is a criterion that will be considered when applications are reviewed, whereby project proposals with matching dollars will be evaluated more favourably than those with in-kind donations. If applicants indicate in-kind contributions, they are required to describe how they are valued. Land values cannot be used as in-kind matching funds.
