## **NSERC John C. Polanyi - 2019 Competition**

### **Sponsor**

Natural Sciences and Engineering Research Council of Canada (NSERC)

The NSERC John C. Polanyi Award was created to recognize and support a university researcher or team of researchers whose work has led to a recent outstanding Canadian advance in a field of the natural sciences or engineering.

### **Eligibility**

The nominators must be Canadian citizens or permanent residents of Canada. Self-nominations will not be accepted. Current NSERC Council members are not eligible for nomination.

In the case of a team nomination, members may be from academia, government or industry, and may be research associates, postdoctoral fellows or students. The team can be part of an international effort, but the majority of the nominated team members must be employed at a Canadian university or public or private organization.

An individual or team may be nominated for the NSERC John C. Polanyi Award and other major NSERC prizes in the same year, but can receive only one such prize in a given year.

### **Prize**

Research grant of up to \$250,000.

### **Special Notes**

The College Dean or VP research can serve as a nominator. If the nominees wish the VP to serve as their nominator, please submit your application package by the internal deadline stated.

If you wish to nominate a colleague or to be considered for VPR nomination, please alert your Associate Dean (Research) and submit an Expression of Interest (EOI) by the internal deadline.

An Expression of Interest will include:

- A draft letter (two-three pages) addressed to the VPR which outlines how you/your nominee meets the criteria outlined on the [NSERC website](#).
- an up-to-date CV (up to 10 pages) for nominee (and each member of the team, if applicable);

?If your nomination will be submitted by a different nominee, and therefore does not require the Vice-President's endorsement, please submit OR-5 and complete nomination by the external deadline.
