Contributions Program 2019-2020 [1]

Description

The Office of the Privacy Commissioner of Canada (OPC) has issued a call for proposals under its 2019-2020 Contributions Program, which funds independent privacy research and related knowledge translation initiatives. OPC is inviting research and knowledge translation applications that advance its strategic privacy priorities. In addition, the OPC is interested in funding one or more "design jams" on consent, meaning design sessions on the topic of consenting to the use of personal information. All proposals must address issues that fall within the scope of the federal Personal Information Protection and Electronic Documents Act [2] (PIPEDA).

Eligibility

Academic institutions and not-for-profit organizations including industry associations and trade associations, are eligible under the Program for funding of research and related knowledge translation initiatives concerning the promotion of privacy and the protection of personal information. Eligible applicants include consumer, voluntary and advocacy organizations.

Funding Availability

The budget for OPC's Contribution Program is \$500,000 annually, which is fully being made available under the present call. Up to \$100,000 may be provided to a successful proposal or set of proposals involving the organization of "design jams." And at least \$400,000 is being made available for all other research and knowledge translation projects, up to a maximum of \$50,000 per research or knowledge translation project.

The maximum amount that may be allocated to any single recipient organization is \$100,000.

Project Duration

The OPC Contributions Program is structured to provide funding for eligible expenses that are incurred within the same fiscal year that funds have been awarded—that is between April 1, 2019 and March 31, 2020. Incurred expenses must have been paid by the Recipient before they are invoiced to the OPC. Exceptionally, the OPC may fund projects that extend beyond the end of the fiscal year (i.e. March 31, 2020) if the proposal persuasively demonstrates why the project requires more time to be completed and should be funded beyond the typical one-year period. For multi-year proposals, applicants are requested to submit work plans that cover the entire duration of the project.
