Description

The Order of Ontario is the province's highest honour. It is reserved for Ontarians from all fields of endeavour and backgrounds, whose excellence has left a lasting legacy in the province, Canada and beyond. Members of the Order are a collective of Ontario's finest citizens, whose contributions have shaped – and continue to shape – the province's history and place in Canada.

Members of the Order of Ontario are invested with their insignia by the Lieutenant Governor as the Queen's representative.

Upon admission, members are invested with the Order's insignia (a distinguishing mark or emblem worn to signify membership or achievement). Appointees are given the post-nominal letters, also called post-nominal initials or post-nominal titles (letters placed after a person's name) to indicate the honour held by the individual.

Eligibility

To be eligible for the Order of Ontario, a nominee must be:

- a long-term or former resident of Ontario (the nominee does not need to be a Canadian citizen)
- someone whose career, in any field, has had a major impact or influence on the province, Canada or abroad

You cannot nominate:

- yourself
- someone who is deceased
- an elected federal, provincial or municipal representative while they are in office
- a volunteer
- someone for acts of bravery

How to Apply

If you wish to nominate a colleague or to be considered for VPR nomination, please submit an Expression of Interest (EOI) by the internal deadline.

An Expression of Interest will include:

- A draft letter (two-three pages) addressed to the VPR which outlines how you/your nominee meets the criteria outlined on the program website [3];
- A short letter or email from your Associate Dean (Research) or College Research Manager indicating the College's support for the nomination; and
- an up-to-date CV (up to 10 pages) for the nominee (and each member of the team, if applicable).
