The letter is intended to notify researchers and institutions of new research security measures that are being developed following the <u>Tri-ministerial statement on protecting Canada's research</u> issued on February 14, 2023.

Note that these new measures have not yet been implemented. Clear guidance will be provided by the Government of Canada in the coming months to ensure that the research community can appropriately comply with these new measures once they are implemented.
