### Knowledge Translation / Knowledge Mobilization

[Integrated knowledge translation](#) [6] and [knowledge mobilization](#) [7] are terms used by CIHR and SSHRC that speak to integrating stakeholders throughout the entire research process as a means of increasing the likelihood of adoption and uptake of research results. Applicants are encouraged to access resources related to these concepts which can be found on the CIHR and SSHRC Web sites.

## Description

Healthy and Productive Work, a joint initiative of the Canadian Institutes of Health Research (CIHR) and Social Sciences and Humanities Research Council (SSHRC), is aimed at driving innovative, evidence-informed and gender responsive solutions to work and labour market challenges to improve the health and productivity of Canada's diverse workforce. The first phase of a two-phase call for applications under Healthy and Productive Work has now been launched.

## Eligibility

The Nominated Principal Applicant must be registered at an eligible institution (See [Institutional Eligibility Requirements](#) [8] for eligibility process and associated timelines).

**Phase 1:** Applications must be submitted to SSHRC's Partnership Development Grants funding opportunity. Applicants (project director) must be affiliated with an eligible Canadian university at the time of application. In addition, the team MUST reflect expertise in BOTH health AND social science and/or humanities domains.

**Phase 2:** Partnership Development Grant holders funded through the Healthy and Productive Work Initiative will be invited to submit a formal proposal to SSHRC's Partnership Grants in 2017. Unlike typical Partnership Grant teams, they will not be required to submit a letter of intent (LOI).

As is the case in the context of Partnership Grants, applications submitted to this initiative are submitted on behalf of a formal partnership. A formal partnership is defined as a bilateral or multilateral formal collaboration agreement between one or more eligible Canadian universities and one or more non-academic partner organizations from the public, private, and/or not-for-profit sectors. Partnerships must also be multidisciplinary and involve researchers from the health and social sciences and/or humanities domains.

## Funding Availability

- The total amount available for Phase 1 is **\$3,000,000**, which will result in approximately 20 Partnership Development Grants. The maximum value per grant is **\$75,000** per year for up to two years.
- It is anticipated that the total amount available for Phase 2 Partnership Grant funding will be **\$11,400,000**, which will fund approximately 8 Partnership Grants. The maximum value of each grant is expected to be **\$325,000** per year over four years, plus an

additional year valued at up to \$125,000 for connection activities (e.g., workshops, colloquiums, conferences, forums or other events or outreach activities).

### Maximum Project Value

**Phase 1:** Partnership Development Grants are valued at up to \$75,000 a year for two years. A total of \$3,000,000 will be made available for this initiative. Each grant will be jointly funded by SSHRC and CIHR. The maximum annual investment per project will be \$50,000 from CIHR and \$25,000 from SSHRC.

**Phase 2:** It is anticipated that the total amount available for Phase 2 Partnership Grant funding will be **\$11,400,000**, which will fund approximately 8 Partnership Grants. The maximum value of each grant is expected to be **\$325,000** per year over four years, plus an additional year valued at up to \$125,000 for connection activities (e.g., workshops, colloquiums, conferences, forums or other events or outreach activities).

### Indirect Costs

There are no indirect costs on the funding provided by SSHRC, however, indirect costs may apply to the funding provided by partners.

### Project Duration

Two (2) years for Phase 1; Four (4) years for Phase 2.
