The Office of the Privacy Commissioner of Canada's (OPC) Contributions Program funds independent privacy research and related knowledge translation initiatives. Researchers are encouraged to propose projects that generate new ideas, approaches, and knowledge about privacy that organizations can apply to better safeguard personal information and that individual Canadians can use to make more informed decisions about protecting their privacy.

The Program's objectives are to:

1. Strengthen existing privacy research capacity in academic and not-for-profit sectors;

2. Generate new knowledge and support the development of expertise in selected areas of privacy and data protection;

3. Increase awareness and understanding among individuals and organizations across Canada of their privacy rights and obligations; and,

4. Promote uptake and application of research results by relevant stakeholders.

Projects funded under this call must be completed no later than March 31, 2017.
